### What is CDBG-DR?

The Community Development Block Grant – Disaster Recovery (CDBG-DR) program, managed by the United States (US) Department of Housing and Urban Development (HUD), provides eligible recipients with federal funding for long-term disaster recovery. This unique program supports a broad range of recovery-related activities and helps communities develop housing and infrastructure programs to address long-term recovery needs.

#### **Funding Availability**

CDBG-DR funds are allocated in response to certain major declared disasters. HUD evaluates unmet recovery needs using data from various other federal agencies and then distributes funds to eligible states, local governments, and tribal entities based on these assessments.

#### How Can You Use These Funds?

Historically, CDBG-DR funding has been primarily utilized to restore housing in disaster-impacted areas. Eligible activities for housing recovery include:

- Rehabilitation, reconstruction, or new construction of single-family or multifamily units;
- Small rental repair programs;
- Homebuyer assistance and home elevation programs; and
- Buyout programs for properties in high-risk areas.

In addition to these housing efforts, CDBG-DR funds can be leveraged to enhance resilience and reduce the impact of future disasters.

Other key areas eligible for investment include:

- Infrastructure improvements;
- Economic revitalization projects;
- Public services support; and
- Strategic planning for long-term recovery and mitigation.
