Case Studies

Preparing for the Future: Pandemic Response AAR

Hagerty supported a large hospital system in St. Louis, Missouri, during COVID-19, identifying key areas for improvement such as public information, resource management, staffing, and technology integration. We led the hospital's AAR effort, collaborating with staff to gather feedback and generate insights. These findings helped the Incident Management Team (IMT) address challenges and enhance operational efficiency in real time.

Increasing Resilience: Risk and Gap Assessment

After responding to the first wave of COVID-19, a prominent Rhode Island healthcare system engaged Hagerty for a Risk and Gap Assessment. We evaluated their emergency management program's compliance with TJC and CMS standards while incorporating local best practices. Hagerty also conducted an HVA to satisfy reporting requirements and identify future risks, strengthening resilience for future challenges.

Staff Augmentation: Statewide Response Operations

In July 2020, Hagerty deployed over 200 professionals to assist a state's Department of Health and Human Services (HHS), Department of Public Health (DPH), and Emergency Medical Services Authority (EMSA) during the COVID-19 response. Our team supported clinical interventions, medical surge operations, communications, and vaccine distribution to maintain a resilient healthcare system throughout multiple COVID-19 surges.
